On March 15, 2013, LifeLine took over management of Fulton County Animal Services. As the managing vendor, LifeLine oversees both the shelter and animal control services. With an expressed commitment to operationally implement a fundamental philosophical shift to prioritize lifesaving, LifeLine has lowered the euthanasia rate by over 50% in Fulton County since taking over. In 2014, our shelter staff adopted out 2,648 new pets, transferred 1,930 animals to rescue groups and returned 843 cats and dogs to their owners. Additionally, LifeLine's animal control team responded to approximately 27,000 calls from Fulton County residents.

On July 1, 2013, LifeLine took over management of DeKalb County Animal Services. As the county's first outside managing vendor, LifeLine runs the animal shelter and the county manages animal control services. Despite facing the significant operational shortcomings of the undersized and outdated shelter, LifeLine successfully lowered the euthanasia rate by over 50% and is consistently saving approximately 85% of the animals taken in each month. In 2014, our shelter staff adopted out 2,024 new pets, transferred 2,350 animals to rescue groups and returned 955 cats and dogs to their owners.

The LifeLine Spay & Neuter Clinics are vital to reducing the number of unwanted animals entering Atlanta's shelters by offering low-cost and no-cost services to Atlanta's pet owners and rescue organizations. Our two (2) clinics have performed over 80,000 surgeries to date. In 2014, we performed 12,282 surgeries. LifeLine has established itself as an invaluable partner for other grassroots animal rescue and spay/neuter efforts in the Atlanta area, performing discounted surgeries and offering financial assistance to the public for spay/neuter.
