

Raffle Rules & Regulations

General Information: Raffle entries are one (1) for \$100, five (5) for \$430, or SIXTEEN(16) for \$1,200. No limit on number of entries. For the first drawing, purchase raffle entries online at LifeLineAnimal.org/beyonce from April 3-April 17, 2025 11:59pm. For the second drawing, raffle entries will be available at the Good Human Gala on April 26, 2025.

100% of raffle entry net proceeds benefit LifeLine Animal Project. Winner will be drawn April 18, 2025 at 12:00pm EST.

Official Rules and Regulations This raffle and fundraiser is conducted by LifeLine Animal Project, P.O. Box 15466, Atlanta, GA 30333, a non-profit and registered 501(c)(3) organization ("LifeLine"), according to the terms of the Charitable Raffle Enabling Act, is subject to all applicable laws and regulations and is void where prohibited. All net proceeds from the entries will benefit LifeLine. Purchased entries are not tax deductible, nor considered a donation to LifeLine.

ELIGIBILITY: The Raffle is open to all legal residents of the fifty (50) United States and the District of Columbia who are eighteen (18) or older as of the date of the entry. THE RAFFLE IS VOID WHERE PROHIBITED. LifeLine has the right to request photo identification from any person desiring to enter the Raffle and reserves the right to require additional identification and may choose to accept or reject any entry based on the identification presented. Entrants are subject to, and by participating in the Raffle, agree to be bound by these Official Rules and Regulations. Officers, directors and employees or agents of LifeLine and members of their immediate families (defined for these purposes as including parents, spouse, children, siblings, grandparents, and each of their respective spouses) or households (whether related or not) of any of the above, are NOT eligible to enter or win.

PRIZE: The prize is two (2) tickets in the Buckin' Honey Pit, on either Thursday July 10, or Sunday July 13, to Beyonce's Cowboy Carter concert at Mercedes Benz Stadium in Atlanta, Georgia. The prize does NOT include food or beverage, lodging, parking, or transportation to or from the venue. LifeLine, its officers, members, agents, and employees as well as any related sponsors are not responsible and bear no liability in the event of the delay, rescheduling or cancellation of the concert Prize.

ENTRIES: Raffle entries for the first drawing are one (1) for \$100, five (5) for \$430, or sixteen (16) for \$1,200 and are available for purchase only during the raffle period of April 4, 2025 at 9:00 am EST through April 17, 2025 at 11:59 pm EST. Raffle entries for the second drawing are one (1) for \$100, five (5) for \$430, or sixteen (16) for \$1,200 and are available for purchase only during the raffle period of April 26, 2025 at 9:00 am EST through April 26, 2025 at 8:30 pm EST. **Entries for the first drawing WILL NOT carryover to the second drawing. Second drawing entries must be present at the Good Human Gala on April 26, 2025 to win.**

To enter, go to LifeLineAnimal.org/beyonce. Raffle entries purchased online incur an additional processing fee. You will need to have a valid credit card to purchase entries. Successfully complete the online raffle registration form with your name, address, phone number, birth date, credit card payment information, and submit. No mechanically reproduced or incomplete entries will be accepted or be eligible. No mail-in or manual raffle purchases are allowed.

For the April 18th, 2025 drawing, all electronic entries must be received by April 17, 2025 at 11:59 pm EST. For the April 26th, 2025 drawing, all entrants must be present at the Good Human Gala to win. For each raffle entry purchased, the person whose name and information is listed on the entry form will receive one (1) entry into the raffle drawing. Raffle tickets or entries cannot be re-sold or given away to another person or party. Only the registered name on the winning entry that is drawn will be allowed to claim the Prize. Odds of winning are based upon the total number of raffle entries purchased during the stated raffle period. LifeLine, its officers, members, agents, and employees as well as any related sponsors are not responsible for lost, late, garbled, or misdirected entries, printing errors, server unavailability, computer or any other electronic malfunction. Any entries received that are duplicate, mutilated, tampered with, incorrect, illegible, or from ineligible entrants will be void. Winner of the second drawing will be selected by a random drawing on April 26, 2025 and will be notified by email the same day. There is no cash alternative prize available. All raffle winning decisions are final.

DELIVERY AND ACCEPTANCE OF PRIZE: Prize is provided "AS IS" without any express or implied warranty of any kind. LifeLine reserves the right to require additional identification and may choose to accept or deny awarding any prize based on the identification presented. Winner cannot assign Prize to another person for any reason whatsoever. Tickets will be furnished to the winner via their associated email address provided at the time of raffle ticket purchase. Failure to do so, for any reason whatsoever, shall result in forfeiture of the Prize and an alternate winner can be selected. Winner is responsible for any applicable taxes and fees including state and federal sales or income tax where applicable. Winner must provide a W9 upon acceptance of PRIZE.
