LIFELINE IS THE MANAGING VENDOR OF FULTON COUNTY ANIMAL SERVICES AND OVERSEES BOTH THE SHELTER AND ANIMAL CONTROL SERVICES IN FULTON COUNTY, GEORGIA. WITH A STRONG COMMITMENT TO IMPLEMENTING A FUNDAMENTAL PHILOSOPHICAL SHIFT TOWARD LIFESAVING, LIFELINE HAS LOWERED THE EUTHANASIA RATE IN FULTON COUNTY BY OVER 90% SINCE TAKING OVER IN 2013. IN 2024, LIFELINE'S SHELTER STAFF ADOPTED OUT 4,154 NEW PETS, TRANSFERRED 2,280 ANIMALS TO RESCUE GROUPS, AND RETURNED 1,228 CATS AND DOGS TO THEIR OWNERS. IN 2024, LIFELINE ACHIEVED AN 89.3% SAVE RATE FOR ALL ANIMALS ENTERING THIS OPEN-ADMISSION ANIMAL CONTROL FACILITY.

AS THE COUNTY'S FIRST OUTSIDE MANAGING VENDOR, LIFELINE OPERATES DEKALB'S ANIMAL SHELTER, WHILE THE COUNTY MAINTAINS ANIMAL CONTROL ENFORCEMENT OFFICERS. LIFELINE HAS SUCCESSFULLY LOWERED THE EUTHANASIA RATE BY 70%, INCREASED PET ADOPTIONS BY MORE THAN 300%, AND IN 2024, SAVED 88.3% OF ALL ANIMALS ENTERING THE SHELTER. IN 2023, LIFELINE'S SHELTER STAFF ADOPTED OUT 4,681 PETS, TRANSFERRED 1,843 ANIMALS TO RESCUE GROUPS, AND RETURNED 1,061 CATS AND DOGS TO THEIR OWNERS.
